The following amendments are made to the University's **Revised Composition of IQAC** vide Ref. No. U-722/SVSU/2026/5173 dated 17.07.2026:

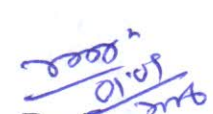

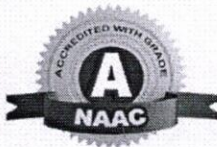

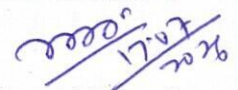
