1. A Faculty Board Meeting chaired by Dr. Jayant Shekhar, Principal SITE was held on 09 Nov. 2016 at 2.00 PM in Principal Office, SITE. During the Meeting the following were present:

2. At the onset, the Principal welcomed all Members who attended the Meeting to consider are urgent issues relating to the day to day functioning of the Department of the Institute.

3. The Board expressed deep concern on the issue of steep decline in the admissions in the IT/ECE/EEE Departments at the B.Tech level and at the M.Tech level in the ECE Department in the Microelectronics, RF and MW Engg; in the ME Department in the CAD/CAM and Thermal Engineering, in the EEE Department in the Power Electronics and Energy Technology and in the Environment Department Environmental Engineering and Management branches, as students are not found interested for admission in these branches due to low demand of these branches in the Industries/Market at present. These branches are recommended to be kept on hold to explore possibilities of improvement in the admissions, in the next two years instead of deciding abrupt closure of the courses which may not be in the best academic interests.

4. Members of the Board expressed the dire need to strengthen academics and resolved to take following steps to contain decline in the admissions in the coming years:

(i). All syllabi pertaining to the semester be uploaded on University website

(ii) Students to be appraised regarding what part of the syllabus is being covered by the concerned faculty in the current lecture.

(iii) Time table of each class should be reshuffled so that in first half of the time table classes of each lab and its connected subject are engaged in the class with each period of 2-hours duration. More stress on Lab is to be given to strengthen teaching of the related theory subjects. Periods in the second half may be assigned to subjects in which there is no connected practical subject prescribed in the semester.


(iv) Students defaulting in dress code, fee payment or discipline should be strictly disallowed entry within precincts of the SITE. List of those defaulting in the registration and/or payment of the Tuition Fee etc. should be sent by respective Departments to Principal for strict action as per rules.

(v) Senior Teachers should be associated with the teaching of First Year. Senior Teachers should also be involved in guiding Resume/PDP preparation to Final Year students. The Meeting then concluded with thanks to the Chair.
