

1. Change in curriculum:

 Principal SMC proposed few change in curriculum of M.Sc. Medical Anatomy, Medical Physiology, Medical Biochemistry, Medical Pharmacology and Medical Microbiology. For admission in M.Sc. Medical subjects, applicants having BNYS degree can be included but B.Sc. MLT and B.Sc. MIT are not eligible.

- Dissertation should be submitted in final year, six month before the examination and it has to be assessed by two internal evaluators other than supervisor and co-supervisor.
- M.Sc. MIT ordinance number (V-73), B.Sc. MIT ordinance number (V-71) have been approved
 by honorable Vice Chancellor and sent to academic council for ratification.
