At the onset, the Chairperson BOS welcomed all the members and thanked outside expert for sparing his time. Following items were taken up as per agenda.

- 3. Item No. 3: To review any change in the curriculum all the courses and starting of any new course no changes required in curriculum of various courses.
- 4. Item No.4: To increase student teacher interaction time in the practical classes.
- 5. Item No. 5:
 - a) New curriculum has been implemented from MBBS 2019 Batch.
 As per new regulation & CBME there will two theory paper of 100 marks each (Total 200) & Practical of 100 marks (Including grand viva)

Following is the proposed distribution of syllabus -

Paper I - General Pathology, Haematology

Paper II - Systemic Pathology, Clinical Pathology

Each theory paper will have 2 or 3 sections according to No. of students 100/150 students respectively.

Section A & B each will be of 50 marks for 100 students. There will be 3 sections in each paper in case of 150 students. Following is the distribution of marks — Suggested distribution of marks may vary as per the number of students in the batch.

For 100 students batch each paper shall be divided into two parts:-

Section A - 50 marks (including 20 marks for MCQs)

Section B - 50 marks

For 150 students batch each paper shall be divided in to three parts:-

Section A - 40 marks (including 20 marks for MCQs)

Section B - 30 marks Section C - 30 marks

Practical - (100 marks) Following is the breakup of marks -


1) Spotters / OSPE stations	-	20 marks
2) Haematology Exercise	-	15 marks
3) Clinical Pathology Exercise	-	15 marks
4) Blood Banking Exercise	-	10 marks
5) Histopathology slides	-	10 marks
6) Log Book / Practical manual	-	10 marks
7) Viva	_	20 marks

- b) As duration of course has reduced to 1 year from 1.5 years and time table is rigid due to which we have to take classes strictly on the basis of scheduled time, so we have to be to the point in our teaching learning sessions. This provides less time for proper discussion and problem solving of the students. Hence it was suggested by the faculty to atleast increase this teaching time to 12 months excluding examination time.
- c) Circulation of microphotographs of handmade diagram and questions for the respective topic to be taught in each practical class, to the students on Whatsapp messenger, one day before the practical's has been implemented. The students are instructed to complete the diagrams and then come to the practical classes to save time.
- d) As mentioned in previous minutes of meeting of BOS as there has been a change in the teaching pattern as well as upgraded software for reporting has been installed, so a strong Wi- Fi connection is required in the department for uninterrupted working of the department.
- e) Since the Pathology curriculum has changed under the NMC more number of faculty will be required for better compliance of the schedule. There is lack of flexibility in the new time table in case of any unavoidable situation or some unscheduled leave and this problem was reported in the previous meetings also and is still persisting.
- f) At present the Pathology postgraduate students have mandatory rotational postings in department of Microbiology, biochemistry and Anatomy. It was suggested by the faculty to also start minimum 1 week mandatory orientation clinical postings (specially surgery, radiology, medicine) for the residents.
